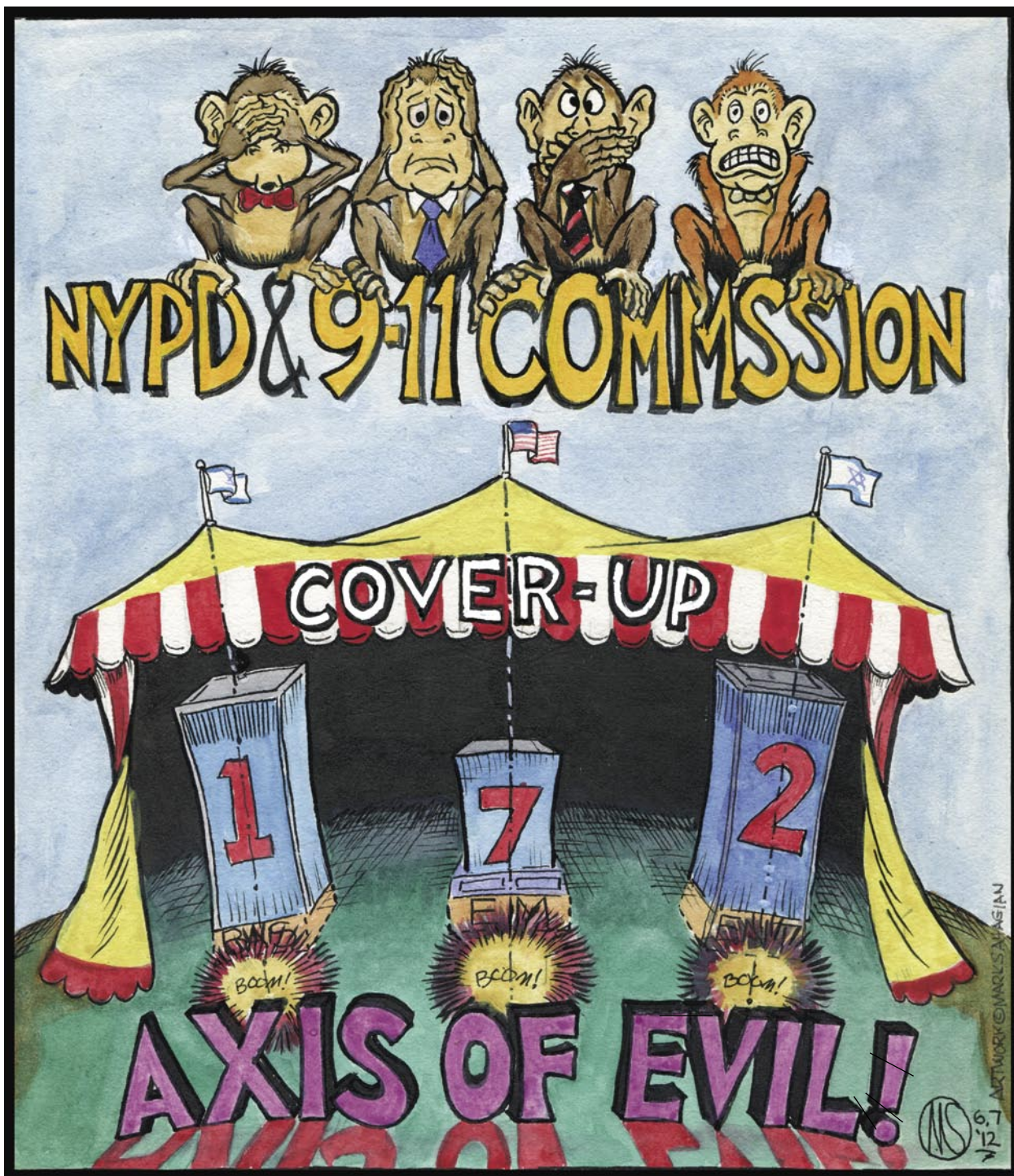

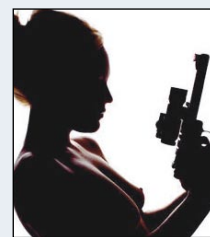

Progressive Democrats Love Obama's Drone Wars

Imagine if the New York Times had run a story late in the spring of 2008 revealing that the Bush administration, including Karl Rove, met weekly to mull a "kill list" of suspected "jihadists". One can be sure that congressional Democrats and liberals would be apoplectic. There might even be people marching in the streets. Yet now, the antiwar left is silent.

Michael Cohen gloats in Foreign Policy that the "kill list" will not hurt President Obama politically because "Americans don't just like drone warfare—they love it." He cites a Washington Post poll from February 2012 that found that 83 percent of Americans approve of Obama's drone policy, including 77 percent of liberal Democrats. But approval is not the same as love, and liberal support for Obama may well resemble conservative support for President Bush's attack on Iraq in 2003: broad, shallow and short-lived.

Only a fraction of all American liberals have been following the issue closely; they've got other things closer to home to worry about. It is unlikely that most of the President's liberal supporters even knew much about the drone war beyond what pollsters told them. It has only been since Obama's Counter-Terrorism Czar John Brennan's speech in late April 2012 that the drone war has been publicly acknowledged in any detail. In the absence of a

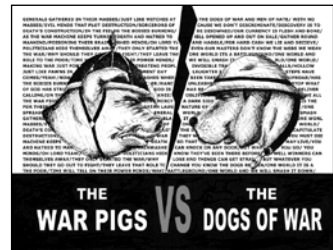

Seek 9/11 Justice At Your Own Risk

Almost every 9/11 Truther has called for a new investigation into the events of 9/11 and many believe that a criminal trial will eventually bring the real perpetrators to justice. Before they get their hopes up, they should study the plight of the Christic Institute, which was a public interest law firm founded in 1980 by Daniel Sheehan. The firm had gathered tons of information on events surrounding the famous Iran Contra scandal. Basically, Sheehan's group discovered how officials responsible for illegal covert activities were winning lucrative federal contracts by transporting goods to the Mujahideen in Afghanistan and the Contras in Nicaragua. Christic also uncovered evidence that the CIA was involved in assisting and carrying out a series of political assassinations. In 1986, Sheehan submitted to the courts an affidavit detailing the scandal. A massive Racketeer Influenced and Corrupt Organizations Act (RICO) lawsuit charged that terrorist bombings were being carried out as part of a conspiracy by a "secret team" that had been operating in the shadows of US intelligence since the 1950s, outside of government oversight. Days before the trial was to begin, a judge dismissed the case, claiming Christic's attorneys had failed to present evidence and eventually ordering Christic to pay over \$1 million in court costs for the defendants, effectively bankrupting the firm. We're still seeing lawyers trying to bring lawsuits regarding the 9/11 criminal conspiracy to court, only to have them dismissed in a similar way. The message is loud and clear. Go after justice for 9/11 in the courts and not only will you lose, you'll be punished. That's what April Gallop and her lawyer, William Veale, found out as their lawsuit against former Vice-president Dick Cheney, former Secretary of Defense Donald Rumsfeld, and former Joint Chiefs of Staff chairman Richard Myers concluded with a final slap in the face. This came in the form of a \$15,000 fine levied against Veale for filing a "frivolous" appeal.

Paul J. Fishman

Paul J. Fishman currently serves as the United States Attorney for the District of New Jersey. He was sworn in on October 14, 2009, having been appointed by Obama after the position was vacated by soon-to-be NJ Governor Chris Christie. Fishman previously served as First Assistant US Attorney from 1991 to 1994 under Michael Chertoff, who would later become Director of Homeland Security and who has made some very suspicious comments about the events of 9/11. Fishman spent eleven years as an assistant US Attorney, serving as chief of the Criminal and Narcotics Divisions of the Justice Department as part of the "War on Drugs", which is nothing more than a war on the Bill of Rights and the American people. In 1993, Fishman headed to the Justice Department in Washington, where he worked under Jamie Gorelick and was a senior adviser to Attorney General Janet Reno. The high-profile cases during his tenure included the federal assault on a family living in a cabin at in Ruby Ridge, Idaho. Also, a House Government Reform Committee report released in 2000 alleged that Reno misled the public for years with claims that military experts endorsed the "flawed" FBI tear-gas attack that tragically ended the Branch Davidian siege in 1993. In 1997 Fishman started a private practice as a white-collar defense attorney. His clients have included Carla Katz, the NJ state labor leader and ex-girlfriend of former Governor Jon Corzine. After his appointment as US Attorney, he was approved unanimously by both parties, whose officials gushed with praise at his swearing in ceremony. In *Jersey Sting*, a book about the most horrific corruption scandal in NJ history, the authors refer to Fishman as Michael Chertoff's top Lieutenant—fittingly, since Chertoff also attended his swearing in. During his acceptance speech, Fishman claimed that terrorism and national security are "his number one priority."

explains the lawsuit: by the **Muslim Advocates. I reviewed this lawsuit: "Syed Farhaj Hassan, The Council of Imams in New Jersey, Muslim Students Association of the U.S. and Canada, Inc., All Body Shop Inside and Outside, Unity Beef Sausage Co., Muslim Foundation, Inc., Moiz Mohammed and Jane Doe vs. The City of New York (NYPD)"** was filed 6/6/12 in the U.S. District Court, Newark, N.J.. The lawsuit claims that the NYPD, with the approval of several N.J. police departments, "began a secret spying program in 2002 to infiltrate and monitor Muslim life in and around New York City. The department has focused, in particular, on New Jersey Muslims; conducting surveillance of at least twenty mosques, fourteen restaurants, eleven retail stores, two grade schools and two Muslim Student Associations. In addition to untold numbers of individuals who own, operate and visit those establishments... The NYPD also uses undercover officers and informants to infiltrate and survey Muslim communities, including Mosques, Muslim Student Associations and Muslim-owned businesses. **Plaintiffs bring this lawsuit in order to affirm the principle that individuals may not be singled out for intrusive investigation and pervasive surveillance simply because they profess a certain faith.**"

The plaintiffs claim that the unlawful surveillance by the NYPD has caused fear in the Muslim community that has adversely affected Muslim businesses, Mosque attendance etc.

The "Star Ledger" article explains that the lawsuit came approximately two weeks after N.J. Attorney General Jeffrey Chiesa claimed that the NYPD did not violate any laws. **This decision proves that America is a police state and the U.S. Constitution is worthless.**
