NSA Builds Country's Biggest Spy Center

There are plans for a massive new National Security Agency data center in Utah. They represent the resurrection of the "Total Information Awareness" program that Congress killed in 2003. The new center would target all electronic communications in the world—including those made by American citizens.

The plan is to build computing systems that can suck up every electronic communication on the planet and filter them through a supercomputer that will flag certain conversations, emails, transactions and other items of interest for further review. The original TIA program was so monstrous in scope that after a brief legislative battle, Congress imposed strict regulations on the type of technology that could accomplish its aims, prohibiting it from ever being used against Americans.

The NSA's new data center in Utah will be the most all-encompassing spy machine ever conceived, capable of breaking almost any encryption, reading any email and recording any phone call anywhere in the world, even if it's not made over the Internet. A network of ultrasensitive satellites is to enhance the center's intelligence-finding capabilities with the unique ability to sniff electronic communications from a massive distance.

More troubling still is that the NSA is dumping Americans' communications into the mix, knowingly violating the US Constitution in pursuit of a modern-day Manhattan Project. When Congress struck down the Pentagon's Total Information Awareness program, they nevertheless authorized funding for processing, analysis, and collaboration tools for for-

Who Wrote the National Defense Authorization Act?

It is often claimed by the lamestream media that the Obama Administration asked to remove the language used in Section 1031 of the National Defense Authorization Act (NDAA). Supposedly, they objected to the language that defines the entirety of the United States as a "battlefield" and which allows American citizens to be snatched from the streets, carted off to a foreign detention camp and held indefinitely without trial. David Cohen





WAR, WAR, NEO-CON WAR

The drums are beating in Washington, New York and Jerusalem. The great boss has been in America lecturing to the President, AIPAC, Congress, and the ever-willing media about just how important it is for us all to attack Iran. Just this week a new twist was added. Because no one has been able to substantiate that Iran is in fact even interested in producing a nuclear weapon—including the CIA, NSA, and Mossad—Zionist hawks have changed the reason for war, not unlike “Global Warming” having been switched to “Climate Change”. Added to this is the fact that Israel is making the identical sort of accusations against Iran that they falsely made against Iraq. In 2003 Israel claimed that Iraq was making nuclear weapons at Osirik, which was attacked and bombed; UN inspectors found no evidence of any nuclear production in the rubble of the facility when they inspected it. Israel made the same claims about a facility in Syria; UN inspectors there found no containment vessel, no fence, no water for cooling...no nuclear anything.

The UN recently released the Goldstone Report (whose author, again, happens to be Jewish, AND Israeli). It is specific in listing 37 war crimes and crimes against humanity committed by the Zionist/Likud-run nation. We, the United States, are blocking this report from being referred to the War Crimes Tribunal at The Hague.

Israel’s nuclear facility at Dimona was the product of a Republic of South Africa and Israeli joint venture, with the first test bomb being exploded in the southern Indian Ocean in the early 60s. The Death of Free Speech

I’ve previously reported on the vanishing right to peaceably assemble, now two more rights supposedly guaranteed by the First Amendment are on the verge of being killed. On March 1, 2012 House Resolution (HR) 347 was submitted to the White House for President Obama’s signature. The bill passed the Senate by unanimous consent and had only three “nays” in the House (42 Representatives did not vote). Justin Amash (one of the three to vote against the bill) posted on his Facebook page, “Current law makes it illegal to enter or remain in an area where certain government officials (more particularly, those with Secret Service protection) will be visiting temporarily if and only if the person knows it’s illegal to enter the restricted area but does so anyway.”

HR 347 expands current law to make it a crime to enter or remain in an area where an official is visiting even if the



person does not know it’s illegal to be in that area and has no reason to suspect it’s illegal.

In addition to making it illegal to unknowingly trespass in an area that has been deemed “restricted” it is now

illegal to heckle and possibly even question a “protected” person if law enforcement or Secret Service deems your action as “disorderly or disruptive conduct” and you are “within such proximity to, any restricted building or grounds” or your conduct is such that it “impedes or disrupts the orderly conduct of Government business or official functions”. This bill, which will likely become law, will essentially codify the use of “free speech zones” and criminalize activity such as asking Rick Santorum if he has ever Googled himself.

It is being reported that HR 347 will also “seriously diminish the right of American citizens to petition their government for a redress of grievances by outlawing protests where key government officials or other VIP’s may be nearby.” A violation of this law gets you either a fine or up to ten years in prison. Both, if you dare to exercise your right to bear arms during your protest—as Chris (last name withheld) did during a 2009 protest in Phoenix, Arizona—even if you harmed no one. ❏
