

The MOST Dangerous Assault on Private Property

The most dangerous assault on private property in the history of the United States has just been launched by Barack Obama. Your home... your neighborhood... your freedom of choice are in the crossfire. And I'm doing everything I can to stop it. Let me explain.

As I've warned for 25 years: Agenda 21 promised to "reorganize human society."

People scoff and ask, "how is that possible?"

For most of those years ranchers, the timber industry and folks living in rural areas have learned – they do it by making it impossible to live on the land. Rules, regulations, fines. That's how. By forcing "integration" of people from low income neighborhoods into "upscale" neighborhoods.

How is that done?

Three ways.

- 3. Federal dictates over local home rule.

More specifically, it works like this.

HUD is forcing local communities to work with third party groups to create their planning programs. There are so-called civil rights groups that are all "left-of-center" organizations. These groups then begin to agitate that affluent neighborhoods are "unfair" because people living there have more than those living in poor neighborhoods! They demand that federal subsidized low income, housing be built in those upscale neighborhoods. HUD files law

suits. The civil rights organizations file law suits. The news media is then filled with false reports of unfair housing practices by local officials. Riots may break out. Imagine Al Sharpton, Jesse Jackson and Black Lives Matter demonstrating in your neighborhood.

This is the absolute destruction of private property rights.

It is the destruction of property values that you have worked so hard to build. And watch the peace and safety of your neighborhood disappear. And you aren't even allowed to say such things. In fact, under AFFH rules, Real Estate Brokers are no longer allowed to use such terms as "safe neighborhoods;" "good schools;" or even that the home is
